### **RELEVANT INFORMATION**

On the date hereof, the capital increase deed formalizing the increase of the share capital out of reserves in a total amount of 10,647,265 € resolved by the Company’s annual shareholders’ meeting held on 8 June 2017, in second call, under item 6, point 6.2 on the meeting agenda, has been registered at the Madrid Commercial Register.

It is envisaged that over the coming days the new 10,647,265 shares will be listed on the stock exchanges of Madrid, Barcelona, Bilbao and Valencia through the Electronic Trading System (Continuous Market). The listing of the shares will be disclosed as relevant fact notification.

In relation to the issue of convertible and exchangeable bonds of the Company May 2014 (code ISIN XS1063399700) and in accordance with its terms and conditions, it is placed on record that the capital increase referred to above implies an adjustment to the conversion price from 5.284 € to 5.175 € per share.
