SACYR COMPLETES EL TEPUAL AIRPORT EXPANSION (CHILE)

- **The consortium participated by Sacyr Concesiones has invested €34 million in the improvement and expansion of the Puerto Montt aerodrome**

Santiago de Chile, December 15, 2022.- The consortium Sociedad Concesionaria Aeropuerto del Sur, led by Sacyr Concesiones, has completed the expansion and improvement works of the El Tepual airport in Puerto Montt, with €34 million in investments. The consortium will also oversee the operation and maintenance of the airport for 6 years.

The works included the remodeling and expansion of the airport's passenger terminal area. These improvements, that allowed to increase the surface from 9,000 m² to 16,000 m², included a new jet bridge and two of the existing ones have been replaced. Moreover, other improvements included the expansion of the tarmac, a new control tower was built, along with some new buildings for the Dirección General de Aeronáutica Civil (DGAC). The passengers' terminal building now includes assistance services for reduced mobility users, a tactile paving accessway, free Wi-Fi service, and the seating areas in the boarding rooms were upgraded and now add up to over 1,200.

This expansion will allow to provide better service, comfort, and security conditions of a regional airport with an international character to airlines, passengers, and other users.

The consortium Sociedad Concesionaria Aeropuerto del Sur is 31.9% Sacyr Concesiones, via Concesiones Viales Andinas (62.5%) and the Chilean company Agencias Universales (37.5%).

Sacyr Concesiones

Sacyr Concesiones creates long-term sustainable value for all its stakeholders through its concession assets, which total a current value of 3,000 million euros (according to the valuation carried out at Investor Day in October 2021).

It is the fourth P3 company in the world, according to the ranking of Public Works Financing magazine.

The company demonstrates its ability to successfully execute the projects it addresses, in six years it will put into operation 18 new concessions, the six most relevant coming into operation between 2022 and 2023. This year the construction of the AVO I urban highway in Santiago (Chile) has been completed in Chile; and in Colombia, the Highway to the Sea 1, which connects the city of Medellin (Colombia) with the most important shopping centers in the country, and the Rumichaca – Pasto highway, which promotes the socio-economic development of the Colombian southwest, has been completed in Chile.

Sacyr in Chile

Sacyr's presence in Chile dates back more than 25 years, to when the contract to build and operate the Los Vilos-La Serena highway was awarded in 1996, at the beginning of the P3 System. Since then, Sacyr has invested more than US\$ 7,000 million in various P3 concession projects, where it operates two airports, two hospitals and 9 concession routes totaling more than 2,000 km of roads.

Since 2020, Sacyr Concesiones Water operates five integrated water cycle management companies in the Antofagasta and Metropolitan regions, which provide services to more than 150,000 people.
